**LIBRARY DIRECTOR'S REPORT:**

- **FINANCIAL:** Expenditures are at 67.57 %; Fiscal year is 68.77 % complete.
- Department Head Meetings have resumed. Organized by Interim Town Administrator Wendy Harrison.
- \$2,500 was donated to the Library from The Roger W. Dietrich Memorial Trust.

**NEW BUSINESS**

- Reopening update: When the Library will be able to reopen is still not known. On the advice of Dave Emery, Vernon's Emergency Management Officer, the Town Office Building was closed Tuesday, March 9, 2021, due to a possible COVID exposure. After a thorough cleaning, the building was open again for staff to work on Wednesday, March 10, 2021.

- **A motion was made by Joanne Leveille to enter into Executive Session to discuss the evaluation of a public officer or employee under the provisions of 1 V.S. A. §313(a)(3)].** Seconded by Ian Hefele. Carried 3-0.

- **A motion was made by Ian Hefele that Ellen Hardy and Kristin Bratton be appointed to fill the two unexpired Library Trustee seats until the 2021 Vernon Town Meeting.** Seconded by Joanne Leveille. Carried 3-0.
