## LIBRARY DIRECTOR'S REPORT/FINANCIAL REPORT

Library Director Jean Carr updated the trustees on the Summer Reading Program and this years' success. Fund raising ideas will be discussed in Old Business.

There was discussion regarding the Selectboard's request to have all departments cut their budgets by 5% which would represent a \$3,500 reduction for the Library.

The Capital Plan was reviewed for utilization of funds for the proposed 2018-2019 funding to renovate the children's area. Trustees want these improvements to be made as budgeted.

- An update of the Fall Foliage Plane Ride Raffle was revisited noting that there are still additional funds being received.
- > The cookbook idea as presented in the Library Director's report was discussed. Rita Mudd, volunteer, has generously offered to help with this project. - The annual appeal letter was discussed and edited. The letter and additional materials for mailing will be prepared by November 1, 2017 with Trustees and volunteers stuffing the letter for mailing on November 9, 2017.

- Communication. The Trustees agreed that before any decisions regarding the Library as well as its funding are made, that a full picture is necessary.
- Strategic Planning Meeting. Discussion of a strategic planning meeting was tabled until the October 11, 2017, regular Trustees' meeting.
- ➤ 2018-2019 Budget. The Trustees set a special meeting to review the budget for September 27, 2017, at 4:30 pm to review the budget. Available Trustees plan to attend the Selectboard's budget meeting pm on October 4, 2017, to support the Library's mission.
